In my youth I was plagued with a nightmare for years. In short it goes as follows: I was alone, at night, walking through an open field when I saw stationary lights on the side of a rural road I was approaching. I observed men pitchforking objects out of a pickup truck onto the side of the road. These men did not see me even though I was now close enough to see what they were removing. At first I thought it was overripe melons that were being pitchforked out but was horrified to discover that it was little children with transparent skulls. I was going to speak out against this injustice but did not and woke up. I kept having this nightmare until I started speaking out against injustice and I cannot let today's topic slide any longer.

According to a [U.S.A. data base](#) eight million children are on psychiatric drugs. Over a million are preschoolers 0 to 5 years old, and 274,804 are babies under a year old. These drugs include anti-depressants, anti-anxieties, ADHD's and even anti-psychotics. These are all prescription medications. Who are those responsible for making these diagnoses?
